Resident Membership

One Time Initiation Fee: \$3,000 + tax

Resident Membership includes immediate family (legal spouse and unmarried dependent children up to age 23). This membership includes:

- Full Club Privileges
- Special race event benefits
- Resident members may entertain a total party of six (6) each race day
- Two (2) Pit Passes may be checked out for a period of two (2) hours each race day
- Reciprocal privileges with The Speedway Club at Charlotte Motor Speedway
- Eligibility to join Club Corp for access to selected private country clubs and resorts worldwide

Resident Membership requires spending minimums or dues. You may choose one of the following:

- Monthly Dues: \$92
- Quarterly Spending Minimums: \$485
- Annual Prepaid Spending Minimums: \$1,940
- NOTE: The option for monthly dues, quarterly OR annual spending minimums may be changed in December (one time per year) by the member.
- Initiation Fee and Dues or Spending Minimums include entire family

Non-Resident Membership One Time Initiation Fee: \$2,000 + tax

Non-Resident Membership includes immediate family (legal spouse and unmarried dependent children up to age 23). To qualify for this membership, residence for member and legal spouse must be outside a 100 mile radius of The Speedway Club. This membership includes:

- Full Club Privileges
- Non-Resident members may entertain a total party of six (6) each race day
- Two (2) Pit Passes may be checked out for a period of two (2) hours each race day
- Special race event benefits
- Reciprocal privileges with The Speedway Club at Charlotte Motor Speedway
- This membership is not eligible for Club Corp membership
- Initiation Fee and Spending Minimums include entire family

Membership requires an Annual Prepaid Spending Minimum in the amount of: \$495

Social Membership

One Time Initiation Fee: \$1,500 + tax

Social Membership includes immediate family (legal spouse and unmarried dependent children up to age 23). This membership includes:

- Full Club Privileges (exception: race weeks – no privileges are included)
- Special Club events
- Reciprocal privileges with The Speedway Club at Charlotte Motor Speedway
- This membership is not eligible for Club Corp membership
- Initiation Fee and Dues include entire family

Membership requires Monthly Dues in the amount of: \$57

Corporate Signature Membership

One Time Initiation Fee: \$7,000 + tax

Corporate Signature Membership includes three designees with the ability to add seven additional designees. This membership includes:

- Full Club Privileges
- Special race event benefits
- Privileges for legal spouse and unmarried dependent children up to age 23 are offered to corporate designees with primary designee's approval
- Ability to transfer the membership to another designee within the same company for the current transfer fee at the time of the change
- Corporate Signature members may entertain a total party of six (6) each race day per designee
- Two (2) Pit Passes may be checked out for a period of two (2) hours each race day per designee
- Reciprocal privileges with The Speedway Club at Charlotte Motor Speedway

Individual Corporate Membership

One Time Initiation Fee: \$3,750 + tax

Individual Corporate Membership includes immediate family (legal spouse and unmarried dependent children up to age 23). This membership includes:
